On Amendments to Certain Decisions of the Commission of the Customs Union and Approval of the List of Critical Export Goods

In accordance with Articles 43 and 45 of the Treaty on the Eurasian Economic Union of 29 May 2014, p. 16 and 18 of the Regulation on the Eurasian Economic Commission (Annex 1 to the Treaty on the Eurasian Economic Union of 29 May 2014), and p. 7 and 16 of Annex 1 the Regulation on the Eurasian Economic Commission, approved by Decision No.98 of the Supreme Eurasian Economic Council on 23 December 2014, the Council of the Eurasian Economic Commission has hereby **decided that:**

1. Subparagraph 7.1.33 to be appended to paragraph 7 of the Customs Union Commission Decision No. 130 of 27 November 2009 “On Common Customs and Tariff Regulation in the Eurasian Economic Union” to read as follows:

“7.1.33. Any goods imported to the customs territory of the Union and included in the critical import list approved by Decision No. ____ of the Eurasian Economic Commission Council of _____ 2020.

This preference shall apply to the goods whose customs declaration for the purpose of customs clearance for domestic consumption is submitted on or before 30 June 2020.”

2. In paragraph 15 of the Rules of Exemption from Customs Duties for the Import of Certain Categories of Goods to the Common Customs Territory of the Customs Union, approved by Decision No. 728 of the Customs Union Commission of 15 July 2011, the numbers “7.1.32” shall be replaced with “7.1.33”.

3. The enclosed list of critical import goods shall be approved.

4. This Decision shall enter into force 10 days after its official publication and shall apply to legal relations arising as of 1 April 2020.
