

In the grain sector, with the exception of products managed within tariff-rate quotas, rice trade only will remain subject to import or export licences from November 6th, 2016.

From then on, the monitoring of trade through real flows will replace the tracking through licences, based on data made available by DG TAXUD.

In the meantime, both licences and real flows can be monitored.
