“On amendments to the Annex to resolution of the Government of the Russian Federation of August 7, 2014 No. 778”

The government of the Russian Federation decides:

1. Approve the attached amendments to the Annex to the decree of the government of the Russian Federation of August 7, 2014 No. 778 "on measures to implement decrees of the President of the Russian Federation of August 6, 2014 No. 560, of June 24, 2015 No. 320, of June 29, 2016 No. 305, of June 30, 2017 No. 293, of July 12, 2018 No. 420 and of June 24, 2019 No. 293" (Collection of legislation of the Russian Federation, 2014, No. 32, article 4543; No. 34, article 4685; 2015, No. 26, article 3913; 4856; # 39, article 5402; 2016, # 10, article 1426; # 23, article 3320; # 28, article 4733; # 38, article 5546; # 44, article 6142; 2017, # 22, article 3161; No. 28, article 4164; No. 45, article 6659; 2018, No. 31, article 4996; 2019, No. 26, article 3457; No. 41, article 5724).
2. To the Ministry of agriculture of the Russian Federation:
To develop and approve the procedure for confirming the intended purpose of imported goods - demineralized dry whey with a demineralization level of 90 percent, intended for the production of infant dry milk mixtures (breast milk substitutes), provided for in the Annex to the decree of the Government of the Russian Federation of August 7, 2014 No. 778 "on measures to implement presidential decrees of the Russian Federation of August 6, 2014 No. 560, June 24, 2015 No. 320, June 29, 2016 No. 305, June 30, 2017 No. 293, from July 12, 2018 No. 420 and from June 24, 2019 No. 293" and classified by the HS code of the EAEU 0404;

Approve for 2020 the permitted volume of the import to the Russian Federation of the goods specified in the second paragraph of this item.
3. This regulation applies until December 31, 2020 inclusive.

1 Position:

"from 0401**, from 0402**, from 0403**, from 0404**, from 0405**, 0406	Milk and dairy products (except for specialized lactose-free milk and specialized lactose-free dairy products for dietary therapeutic nutrition and dietary preventive nutrition)"
put in the following wording: "from 0401**, from 0402**, from 0403**, from 0404**, from 0405**, 0406	Milk and dairy products (except for specialized lactose-free milk, specialized lactose-free dairy products for dietary therapeutic nutrition and dietary preventive nutrition, with a dry demineralized milk shortening with a demineralization level of 90 percent*****).".

Add the following tenth footnote:

"***** Demineralized dry milk whey with a demineralization level of 90 percent,
intended for the production of infant formula (breast milk substitutes), with confirmation of
the intended purpose of the imported goods, carried out by the Ministry of agriculture of the
Russian Federation in accordance with the procedure established by it and within the
authorized volume of import of the specified goods approved by the Ministry for 2020."
